



# OFAC & CRYPTOCURRENCY SANCTIONS

The Office of Foreign Assets Control (OFAC) is an office within the U.S. Department of the Treasury responsible for administering and enforcing economic and trade sanctions based on U.S. foreign policy and national security goals.

These sanctions are imposed on individuals, entities, and governments that are involved in activities or transactions considered a threat to the United States. These sanctions aim to restrict targeted individuals or entities from accessing financial assets or doing business within the United States.

## CRYPTOCURRENCY SANCTIONS

---

- In recent years, The OFAC has expanded its efforts to regulate cryptocurrency transactions by including crypto addresses in its sanction's lists. This development is in response to the increasing use of cryptocurrencies by individuals and organizations to evade traditional financial controls and to conduct illicit activities.
- To sanction crypto addresses, The OFAC utilizes blockchain analytics tools and collaboration with law enforcement agencies and cryptocurrency exchanges to track and identify wallet addresses associated with sanctioned entities or individuals.
- When a wallet address is linked to a sanctioned entity, The OFAC can restrict the ability to transact with that address, making it challenging for the targeted entity to use cryptocurrencies for their financial operations.

## CRYPTOCURRENCY SANCTIONS

---



The U.S. Treasury has sanctioned an Ethereum wallet associated with the Sinaloa Cartel. The Sinaloa Cartel is a notorious Mexican Drug Trafficking Organization.



Sanctioning the wallet is a way for the U.S. Government can disrupt their financial activities and hinder their ability to use cryptocurrencies for illicit purposes.



By designating crypto addresses linked to criminal organizations, the U.S. government aims to enhance its ability to track and curtail the illicit use of cryptocurrencies.

Using the Address History Search on Crypto Track Pro we can see a summary of transactions with directions and amounts as well as block numbers and the type of coin/token.

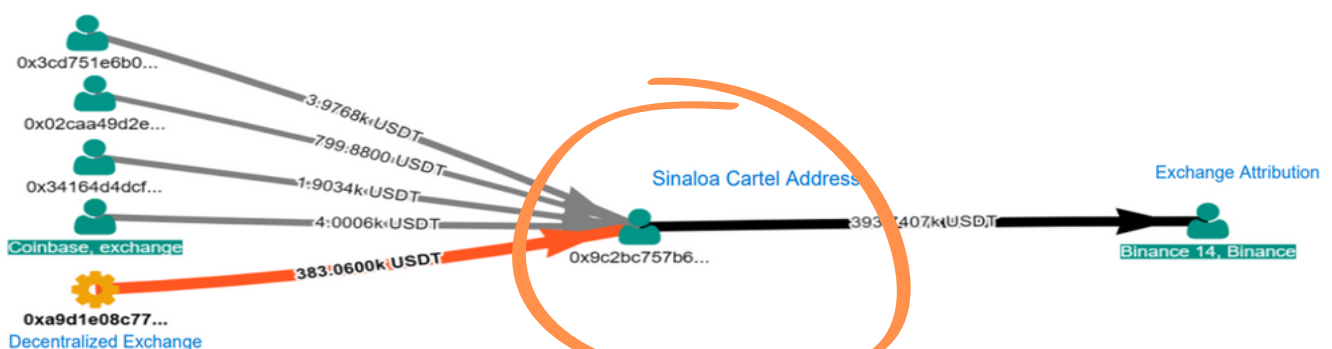
